Contributions must be made from personal or PAC funds and may not be reimbursed by any other person or entity.

Information for Partnerships or LLCs: A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company of up to \$3,300 per election may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's or member's home address.
